Orders in EUR received by 15:00 CET are executed on the same day.

**c. T2 payments**

Orders in EUR received by 15:30 CET are executed on the same day. The recipient's bank receives the payment on the value date indicated on the payment order.

**VIII. GENERAL TERMS**

- The conditions are subject to change without previous notice.
- Tariff rates which are not included in these conditions will be quoted on request.
- Different tariff rates may be applied on reciprocal basis.
- Postage, cable, SWIFT, out of pocket or courier service charges will be added to the rates. The afore mentioned fees and charges apply to normal transactions. SWIFT (EUR 28), postage/courier charges (DHL, TNT, Fedex etc. - according to their rates + EUR 15) will be added to the above rates.
- We reserve the right to levy a special charge when additional work is involved or in the event of special circumstances.
- Nova KBM d.d. shall not honor any claim for MT103 payments which are older than three months.
- Straight-through requirements:

  - field 23B: CRED
  - field 23E: not allowed
  - field 32A: date, currency, amount
  - field 50 (a, k and f): originator
  - field 52 A: BIC, option A only
  - field 54 A: BIC, option A only

  - field 57 A: BIC, option A only
  - field 53: BIC, option A or B possible
  - field 59: IBAN mandatory
  - field 71A: SHA, BEN, OUR
  - field 72: not allowed
- Nova KBM d.d. does not honour OUR charges exceeding EUR 25.
